

RESOLUTION NO. MOB 2012-003

A RESOLUTION OF THE OVERSIGHT BOARD FOR THE MENDOTA DESIGNATED LOCAL AUTHORITY, AS SUCCESSOR AGENCY TO THE MENDOTA REDEVELOPMENT AGENCY, APPROVING THE RECOGNIZED OBLIGATION PAYMENT SCHEDULES (ROPS) FOR THE PERIODS OF JANUARY 1, 2012 THROUGH JUNE 30, 2012, JULY 1, 2012 THROUGH DECEMBER 31, 2012, AND JANUARY 1, 2013 THROUGH JUNE 30, 2013

WHEREAS, the Oversight Board ("OB") for the Mendota Designated Local Authority ("DLA"), as Successor Agency to the Mendota Redevelopment Agency, has been established to take actions to wind down the affairs of the former Redevelopment Agency of the City of Mendota in accordance with the California Health and Safety Code; and

WHEREAS, the Health and Safety Code requires the Successor Agency to prepare and adopt a series of "Recognized Obligation Payment Schedules" that list all obligations of the former redevelopment agency that are enforceable within the meaning of subdivision (d) of Section 34167; and

WHEREAS, the Oversight Board desires to approve Recognized Obligation Payment Schedules (ROPS) for the Periods of January 1, 2012 through June 30, 2012, July 1, 2012 through December 31, 2012, and January 1, 2013 through June 30, 2013; and

WHEREAS, the Oversight Board desires to approve the Recognized Obligation Payment Schedules (ROPS) for the Periods of January 1, 2012 through June 30, 2012, July 1, 2012 through December 31, 2012, and January 1, 2013 through June 30, 2013; and

WHEREAS, all other legal prerequisites to the adoption of this Resolution have occurred.

NOW, THEREFORE, THE OVERSIGHT BOARD FOR THE MENDOTA DESIGNATED LOCAL AUTHORITY, AS SUCCESSOR AGENCY OF THE MENDOTA REDEVELOPMENT AGENCY, DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The Recitals set forth above are true and correct and incorporated herein by reference.

SECTION 2. The Oversight Board hereby approves (i) the Schedule attached hereto as Exhibit A as the Recognized Obligation Payment Schedule for January 1, 2012 through June 30, 2012, (ii) the Schedule attached hereto as Exhibit B as the Recognized Obligation Payment Schedule for July 1, 2012 through December 31, 2012; and, (iii) the Schedule attached hereto as Exhibit C as the Recognized Obligation Payment Schedule for January 1, 2013 through June 30, 2013.

SECTION 3. Mark Persico, or his designee, or any other person employed by Kosmont Companies, which is serving as staff to the Successor Agency of the Mendota Redevelopment Agency, is hereby authorized to submit the ROPS to such parties as may be required in accordance with the Health & Safety Code, and to take such other actions with respect to the ROPS as may be necessary in accordance with applicable law.

SECTION 4. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the invalid provision or application, and to this end the provisions of this resolution are severable. The Oversight Board hereby declares that it would have adopted this Resolution irrespective of the invalidity of any particular portion thereof.

SECTION 5. This Resolution shall take effect from and after the date of its passage and adoption.
