**BACKGROUND**

The Santa Paula Designated Local Authority, as Successor Agency to the Santa Paula Redevelopment Agency (“DLA”), was established by statute to take actions to wind down the affairs of the former Santa Paula Redevelopment Agency in accordance with the California Health and Safety Code.

Leibold McClendon & Mann, PC (LMM) has supported the DLA as General Counsel to the DLA since September 1, 2013 and prior to that as a subcontractor to Kosmont Companies. The DLA requires the legal services of LMM until the business of the DLA is completed so it is necessary to approve a contract for legal services for the period January 1, 2015 through December 31, 2015.

**DISCUSSION**

In order to fulfill its obligations with respect to the wind down of the affairs of the former Santa Paula Redevelopment Agency, the DLA requires the assistance of legal counsel. LMM has been acting as General Counsel to the DLA.

A form of legal services agreement is attached hereto and sets forth the cost, timing and other particulars of the proposed engagement of LMM.

Section 34177(b) of the Health and Safety Code provides that a Successor Agency may create enforceable obligations to conduct wind-down activities of the former Agency, including acquiring necessary professional staff, and legal staff is necessary to comply with the law and work through the various issues confronting the DLA as it winds down the affairs of the former Santa Paula Redevelopment Agency.

## **RECOMMENDATION**

It is recommended that the Oversight Board of the Santa Paula Designated Local Authority, acting as Successor Agency to the Santa Paula Redevelopment Agency, adopt Resolution No. 2014-02 approving a contract between the Santa Paula Designated Local Authority and Leibold McClendon & Mann, PC for legal services from January 1, 2015 through December 31, 2015 and authorizing Sid White, or his designee, to take all necessary actions with respect thereto.

**WHEREAS**, the Santa Paula Designated Local Authority (“DLA”), as Successor Agency to the Santa Paula Redevelopment Agency, has been established to take actions to wind down the affairs of the former Redevelopment Agency of the City of Santa Paula in accordance with the California Health and Safety Code; and

**WHEREAS**, Leibold McClendon & Mann, PC has been acting as General Counsel to the DLA since September 1, 2013 and in its capacity as a sub-consultant to Kosmont Companies since the formation of the DLA; and

**WHEREAS**, in order to fulfill its obligations with respect to the wind down the affairs of the former Redevelopment Agency of the City of Santa Paula, the Designated Local Authority requires the assistance of legal counsel; and

**WHEREAS**, Section 34177(b) of the Health and Safety Code provides that a Successor Agency may create enforceable obligations to conduct wind-down activities of the former Agency, including acquiring necessary professional staff; and

**WHEREAS**, the Oversight Board desires to approve a contract between the DLA and Leibold McClendon & Mann, PC to perform the duties of the office of General Counsel beginning as of January 1, 2015; and

**WHEREAS**, all other legal prerequisites to the adoption of this Resolution have occurred.

**NOW, THEREFORE, THE DESIGNATED LOCAL AUTHORITY, AS SUCCESSOR AGENCY OF THE SANTA PAULA REDEVELOPMENT AGENCY, DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:**

**SECTION 1.** The Recitals set forth above are true and correct and incorporated herein by reference.

**SECTION 2.** The Oversight Board of the Santa Paula DLA, as Successor Agency to the Santa Paula Redevelopment Agency, hereby approves a contract between the Santa Paula DLA and Leibold McClendon & Mann, PC to perform the duties of the office of General Counsel beginning as of January 1, 2015, subject to the terms and conditions set forth in the Agreement for Legal Services attached hereto. Pursuant to Health & Safety Code Section 34173, the Successor Agency’s liability is limited to the total sum of property tax revenues it receives pursuant to Part 1.85 of AB X1 26.

**SECTION 3.** Sid White, or his designee, is hereby authorized to enter into such Agreement for Legal Services on behalf of the DLA and take such other actions as may be required by the Health & Safety Code, and any other actions as may be necessary in furtherance of the foregoing contract in accordance with applicable law.

**SECTION 4.** If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the invalid provision or application, and to this end the provisions of this resolution are severable. The Oversight Board hereby declares that it would have adopted this Resolution irrespective of the invalidity of any particular portion thereof.

**BACKGROUND**

The Santa Paula Designated Local Authority, as Successor Agency to the Santa Paula Redevelopment Agency (“DLA”), was established by statute to take actions to wind down the affairs of the former Santa Paula Redevelopment Agency in accordance with the California Health and Safety Code.

Kosmont Companies (Kosmont) was engaged by the DLA to serve as Staff to the DLA and the Oversight Board through December 31, 2014. The DLA and Oversight Board continues to require the staff and support services of Kosmont until the business of the DLA is completed so it is necessary to approve a contract for staff and support services for the period January 1, 2015 through December 31, 2015.

**DISCUSSION**

In order to fulfill its obligations with respect to the wind down of the affairs of the former Santa Paula Redevelopment Agency, the DLA and the Oversight Board requires the assistance of Kosmont for staff and support services. Kosmont has been acting as Staff to the DLA and the Oversight Board.

A form of staff and support services agreement is attached hereto and sets forth the cost, timing and other particulars of the proposed engagement of Kosmont. The rates are unchanged from the current contract and are detailed in the staff and support services agreement.

Section 34177(b) of the Health and Safety Code provides that a Successor Agency may create enforceable obligations to conduct wind-down activities of the former Agency, including acquiring necessary professional staff, and legal staff is necessary to comply with the law and work through the various issues confronting the DLA as it winds down the affairs of the former Santa Paula Redevelopment Agency.

## **RECOMMENDATION**

It is recommended that the Oversight Board of the Santa Paula Designated Local Authority, acting as Successor Agency to the Santa Paula Redevelopment Agency, adopt Resolution No. 2014-03 approving a contract between the Santa Paula Designated Local Authority and Kosmont Companies for staff and support services from January 1, 2015 through December 31, 2015 and authorizing Sid White, or his designee, to take all necessary actions with respect thereto.

**WHEREAS**, the Santa Paula Designated Local Authority (“DLA”), as Successor Agency to the Santa Paula Redevelopment Agency, has been established to take actions to wind down the affairs of the former Redevelopment Agency of the City of Santa Paula in accordance with the California Health and Safety Code; and

**WHEREAS**, Kosmont Companies has been acting as Staff to the DLA since the formation of the DLA; and

**WHEREAS**, from January 1, 2014 through December 31, 2014, the DLA has contracted with Kosmont Companies to provide staff and professional services for the DLA and the Oversight Board; and

**WHEREAS**, as of December 31, 2014, the DLA contract with Kosmont Companies for staff and professional services expires; and

**WHEREAS**, in order to fulfill its obligations with respect to the wind down the affairs of the former Redevelopment Agency of the City of Santa Paula, the Designated Local Authority requires staffing and professional services; and

**WHEREAS**, Section 34177(b) of the Health and Safety Code provides that a Successor Agency may create enforceable obligations to conduct wind-down activities of the former Agency, including acquiring necessary professional staff; and

**WHEREAS**, the Oversight Board desires to approve a contract between the DLA and Kosmont Companies to perform the duties of staff beginning as of January 1, 2015; and

**WHEREAS**, all other legal prerequisites to the adoption of this Resolution have occurred.

**NOW, THEREFORE, THE OVERSIGHT BOARD OF THE DESIGNATED LOCAL AUTHORITY, AS SUCCESSOR AGENCY OF THE SANTA PAULA REDEVELOPMENT AGENCY, DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:**

**SECTION 3.** Sid White, or his designee, is hereby authorized to enter into such Agreement for Staff and Support Services on behalf of the DLA and take such other actions as may be required by the Health & Safety Code, and any other actions as may be necessary in furtherance of the foregoing contract in accordance with applicable law.

**SECTION 4.** If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the invalid provision or application, and to this end the provisions of this resolution are severable. **BACKGROUND**

The Santa Paula Designated Local Authority, as Successor Agency to the Santa Paula Redevelopment Agency (“DLA”), was established by statute to take actions to wind down the affairs of the former Santa Paula Redevelopment Agency in accordance with the California Health and Safety Code.

Health and Safety Code Section 34169 requires the Successor Agency to prepare and adopt a “Recognized Obligation Payment Schedule” that lists all obligations of the former redevelopment agency that are enforceable within the meaning of subdivision (d) of Section 34167 for six month periods including January 1, 2015 through June 30, 2015.

**DISCUSSION**

AB 1484 requires that the ROPS for January 2015 through June 2015 be submitted to DOF and the State Controller’s office, after approval by the Oversight Board, no later than October 3, 2014. The DOF has five (5) days after submittal to request a review and forty-five (45) days to review the ROPS if it decides to do so. If the ROPS is not submitted by the deadline, the City is subject to a \$10,000 fine for every day the ROPS is late and the administrative cost allowance for the Successor Agency is reduced by 25% after 10 days.

The attached ROPS 14-15B for the period January 1, 2015 – June 30, 2015 follows the form prescribed by the DOF and incorporates the obligations identified in the previous ROPS. DOF has made some changes to the form, and certain items previously listed on the form have been updated.

**RECOMMENDATION**

It is recommended that the Oversight Board of the Santa Paula Designated Local Authority, acting as Successor Agency to the Santa Paula Redevelopment Agency, adopt Resolution No. 2014-04 approving the Recognized Obligation Payment Schedule (ROPS) 14-15B for the Period of January 1, 2015 Through June 30, 2015.

**A RESOLUTION OF THE SANTA PAULA DESIGNATED LOCAL AUTHORITY, AS SUCCESSOR AGENCY OF THE SANTA PAULA REDEVELOPMENT AGENCY APPROVING THE RECOGNIZED OBLIGATION PAYMENT SCHEDULE (ROPS 14-15B) FOR JANUARY 1, 2015 THROUGH JUNE 30, 2015**

**WHEREAS**, the Oversight Board of the Santa Paula Designated Local Authority, as Successor Agency of the Santa Paula Redevelopment Agency (the "Successor Agency") is charged with implementing recognized enforceable obligations and winding down of the affairs of the former Redevelopment Agency of the City of Santa Paula (the "Agency") in accordance with the California Health and Safety Code; and

**WHEREAS**, Health and Safety Code Section 34169 requires the Successor Agency to prepare and adopt a "Recognized Obligation Payment Schedule" that lists all obligations of the former redevelopment agency that are enforceable within the meaning of subdivision (d) of Section 34167 for six month periods, including January 1, 2015 through June 30, 2015; and

**WHEREAS**, AB 1484 requires that the ROPS 14-15B for the period January 1, 2015 through June 30, 2015 must be submitted to the Department of Finance and the State Controller's office, after approval by the Oversight Board, no later than October 3, 2014 or be subject to penalties; and

**WHEREAS**, all other legal prerequisites to the adoption of this Resolution have occurred.

**NOW, THEREFORE, THE OVERSIGHT BOARD OF THE SANTA PAULA DESIGNATED LOCAL AUTHORITY, AS SUCCESSOR AGENCY OF THE SANTA PAULA REDEVELOPMENT AGENCY, DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:**

**SECTION 1.** The Recitals set forth above are true and correct and incorporated herein by reference.

**SECTION 2.** The Oversight Board of the Santa Paula Designated Local Authority, as Successor Agency to the Santa Paula Redevelopment Agency, hereby approves the Schedule attached hereto as Exhibit A as the Recognized Obligation Payment Schedule 14-15B for January 1, 2015 through June 30, 2015. Pursuant to Health & Safety Code Section 34173, the Successor Agency's liability, including, but not limited to, its liability for the obligations on the attached schedule, is limited to the total sum of property tax revenues it receives pursuant to Part 1.85 of AB X1 26.

**SECTION 3.** Christopher Jicha, or his designee, or another employee of Kosmont Companies designated by Larry Kosmont, is hereby authorized to submit the ROPS to such parties as may be required in accordance with the Health & Safety Code, and to take such other actions on behalf of the Successor Agency with respect to the ROPS as may be necessary in accordance with applicable law.

**SECTION 4.** If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the invalid provision or application, and to this end the provisions of this Resolution are severable. The Successor Agency hereby declares that it would have adopted this Resolution irrespective of the invalidity of any particular portion thereof.
